It was noted that a high level land purchase briefing was prepared by DEW for submission to the Federal Government as part of the \$17m shorebirds project.

#### **Discussion**:

It was noted that the Drainage and Wetlands Strategy Committee met at the Mount Burr site and feedback from the Committee members was positivee.

The LC Landscape Board discussed the project potential for the region noting that there are no mechanisms to progress at this stage.

The LC Landscape Board emphasised the importance of evaluating the benefits of this work for the region and suggested a pursuit of external funding opportunities.

The Governing Board discussed that one potential outcome of the Committee's work could involve retention water in the landscape, using Lake George as an example.

It was noted that there are currently no established methods for a simplified carbon credits accreditation system specifically for wetlands that recognise carbon credits.

It was noted that this work will benefit from M Herpich's involvement.

**ACTION:** M Bachmann and P Bissell to provide the LC Landscape Board with the Drainage and Wetlands Strategy Joint Boards Committee priorities shortlisting and potential methodologies to progress with the LC Landscape Board, including shorter meeting sessions, and buying unused water allocation. These discussions can feed into the joint Committee.
